Per the Programmatic Agreement Among the United States Army Garrison, Yuma Proving Ground, the Arizona State Historic Preservation Officer, and the Advisory Council on Historic Preservation Regarding the Operations, Maintenance, and Development of Yuma Proving Ground, Arizona (November 2014) (PA) the United States Army Garrison (USAG YPG) is to prepare an annual report and distribute it to each Consulting Party, except the Advisory Council on Historic Preservation (ACIP), within 75 days of the end of the fiscal year, beginning in Fiscal Year 2016. This document provides responses to Stipulation VIII of the PA.

Ms. Vaughn left YPG in October and we are currently in the process of hiring a new permanent Cultural Resource Manager. Mr. Harris and Ms. Baez also left YPG in 2022, and we are working to fill their positions.

10. Changes USAG YPG might considered towards improvement in implementation of any stipulations.

The Programmatic Agreement expires in 2024 and YPG intends to begin working on a new agreement document in FY 2023. Prior to the start of a new document, letters will be sent to consulting parties informing them of the start of the process.

List of Projects that were exempt per Attachment H and projects that previously were surveyed.

Projects that previously were surveyed were examined to determine that no historic properties were within the current APE. Projects that say "no ground disturbance" are situations where no exemption was appropriate, not ground disturbance was to take place, and no buildings were to be modified, but a Record of Environmental Consideration was required prompting a cultural resource management response. These projects include activities like placing conex boxes in paved parking lots and removal of surface trash. One project was exempted under Attachment C of the Programmatic Agreement due to the types and quantities of historic munitions present in the specific project area. The area is covered under the Attachment C map and the determination that an archaeological survey crew would not be allowed in the area was made by the explosives safety manager. Operations are ongoing in FY 23 to clear any munitions from this area.
